#### Why this form?

With this form you apply for a *permission to apply for VHK stamps*.  
With this permission you can apply for VHK stamps.

VHK stamps must be used, among other things, for Duty Free tobacco products that can be sold through Dutch duty-free shops at airports to travelers traveling to countries outside the EU. Tobacco products made available to consumers within the European territory on ships and in airplanes are generally not Duty Free tobacco products. These products must be provided with a regular tax stamp and not with VHK stamps.
