

Order of the Minister for Foreign Trade and Development Cooperation of 28 October 2018, no. Min-BuZa.2018.1845-16, amending the Order of for Foreign Trade and Development Cooperation of 20 September 2018, no. MinBuZa-2018.1624-18, laying down administrative rules and a ceiling for grants awarded under the Ministry of Foreign Affairs Grant Regulations 2006 (Amendment of Migration and Development 2019-2022)

The Minister for Foreign Trade and Development Cooperation,

Having regard to articles 6, 7 and 10 of the Ministry of Foreign Affairs Grants Decree,

Having regard to article 2.5 of the Ministry of Foreign Affairs Grant Regulations 2006,

Orders:

#### Article I

The annexe to the Order of the Minister for Foreign Trade and Development Cooperation of 20 September 2018, no. MINBUZA-2018.1624-18, laying down administrative rules and a ceiling for grants awarded under the Ministry of Foreign Affairs Grant Regulations 2006 (Migration and Development 2019-2022)<sup>1</sup> is amended as follows:

#### A

The following two sentences are added to paragraph 4.6 under Chapter 4, Formal requirements for applications:

'Overhead costs will be assessed on the basis of the final proposal, based on the actual costs to be incurred, which may depend on the nature and scale of the proposed programme. Grants are awarded solely to cover costs of the planned activities that are necessary in light of the objectives and results envisaged, in so far as it cannot reasonably be expected that such costs can be funded from the applicant's own resources or other sources.'

#### B

In paragraph 5.2 'Threshold criteria concerning the programme (D.6 to D.12,)' under Chapter 5, Selection criteria, criterion D.11 - 'Overhead costs' is deleted and criterion D.12 is renumbered D.11.

#### C

Paragraph 5.4 'The applicant's/consortium partners' track record (T.1 to T.4)' under Chapter 5, Selection criteria, is amended as follows:

1. Criterion T.2 - 'Scope of the activity portfolio in the target country' is deleted.

2. Criteria T.3 and T.4 are renumbered T.2 and T.3, and criterion T.2 reads:

*'T.2 - Experience in the target country with the sub-themes for which a grant is being requested*

The total extent (measured in euros spent) of the applicant's/consortium members' activities in the target country on the sub-theme for which a grant is being requested, in the context of reception in the region or cooperation in migration partnerships during the 2013-2018 period.'
